#### **Town Highways and Equipment Update**

- Tyson Bridge updates. Still waiting for cost estimates from EPA. Jon will get estimates
  for the cost of replacing the bridge, and the cost of a pedestrian bridge, and the cost of
  a bridge with reduced weight limit. Selectboard will investigate the process of changing
  to a pedestrian bridge. EPA to provide estimates for replacement of the deck. Review
  communications with EPA to cover bridge damage. Bridge will need to stay closed till
  repairs are made.
- Paving project updates. Jon is getting updated prices for Miller Pond Road work in the coming days and then repairs can proceed.

# **Ashley Community Forest Project**

Michael Sacca presented the history of the Project. Asked the SB for an article added to the Nov 3 ballot to allow voters to approve acceptance of the land free and clear, with details to be worked out by the Selectboards of the two towns. Town Clerk not clear how this would happen. Motion passed to put to the town a special vote for deciding whether to accept the Ashley Community Forest Land free and clear. Micki noted the historical and educational value of the land.

### PACIF – Town Garage and Town House Assessments

Decide to leave the Town Hall insurance valuation at \$1,721,729; increase Town Garage valuation to \$907,432.

#### **Use of Recreation Fields Requests**

- Motion approved for Creative Pre-School request to maintain tent on Murray Field as long as weather allows
- Motion passed for request for an outdoor dance at Murray Field, for 25 people, 6-8 pm on Saturday Sept 12<sup>th</sup>, COVID social distancing required, pre-registration required to limit participation.
- Motion passed for an Artisan Fair, in lieu of the annual Holiday Sale, to be held October 10th & 11th, 10am-3pm on Murray Field for 20 up to vendors, each vendor in tent, separated by 6 ft, masks required

**Draft review of Ethical Conduct and Conflict of Interest Policy for the Town of Strafford.** VLCT provided a sample document. Eric: State allows Towns to put in place a COI, and VLCT put forward a model policy, which differs in some ways, which Gillies noted. Proposes we dovetail the draft document with VLCT's model, so that language is updated. A new draft will be prepared, incorporating language from VLCT and Gillies, and made available for comment by the town.

## **Dog Officer vacancy and Dog Ordinance changes**

No applicants yet. Discussion undertaken regarding how Orange County Sherriff might assist in enforcement.

# Liaison updates

- Alan Donahue resigned from Development Review Board
- The bottom of Finn Road was re-ditched to force water under the road. Brook Road and Miller Pond Road culverts need to be replaced.
- Town office smell issue still problematic off and on. May be a venting problem, and liaison continues to investigate.

#### Other

- Junk Yard inventory update. Toni and Mary have begun the inventory and continue to gather information.
- Retaining wall behind the Red Barn is starting to collapse and may be a hazard.
   Recreation Board is attempting to the ensure the repair will be conducted before school starts. An anonymous donor will support the repair; no funds are required from town.
