# Selectboard Meeting Minutes March 20, 2025

The meeting starts at 6pm.

Two changes to the agenda: 1. Freeman Road bridge agreement 2. Meyers driveway permit application review.

1. Public Comments: none

- 2. Highway:
  - Vacancies: no potential candidates yet.
  - Equipment: repairing loader and backhoe; set up depreciation schedule to understand life cycle of the equipment
  - Roads are posted.
  - Update on completion of the Town Municipal Impact Questionnaire for Kendal Act 250 Permit Application:
    - Solsaa walks through the various check points that are applicable (fire, police, road, EMT) and not applicable (sewer, trash, water). Will continue to reach out to the various departments for comment.
    - Act 250 Hearing is set for April 9. The questionnaire is to be completed prior to that date.
  - RFP for Brook Road and South Strafford paving:
    - Issue RFP next week with deadline and award by March 31, 2025
    - Solsaa motions to issue the RFP, Pippy seconds and all approve.
    - Emerson road to be included in the Brook Road paving.
  - Award Van Dyke and Ward Bridge Projects:
    - Accent Consulting is Project Manager: 2 bids received; the recommendation is to award the project to Northwoods.
      - Northwoods (adjusted with contingencies) bid is \$368, 494;
        Markowski Excavating (adjusted with contingencies) bid is \$666.289.
      - Solsaa motions to award the bid to Northwoods; Pippy seconds and all approve.
  - Driveway permit on 205 Robinson Rd: Pippy motion to approve the Meyers driveway application, Solsaa seconds and all approve.
  - Freeman Bridge:

- Agreement between the Town and the CCS (contractor) for construction related to Freeman Bridge.
- Solsaa moves to sign the agreement, Linehan seconds and all approve.

 Solsaa motions to accept the meeting minutes of 3/13/25. Duncklee seconds and all approve. Mary Linehan recuses.

- Chair Toni Pippy then moves for the Board to enter executive session to discuss the appeal of Rachel Kendall's application for a conditional use permit under the provisions of Title 1, Section 313 (a)(1)(A) of the Vermont Statutes. Harman seconds, and all approve.
