Selectboard Meeting March 13, 2019 MINUTES

Meeting was called to order at 6:07 p.m.

Election of Officers, Rules of Procedure Reminder

Toni Pippy was nominated as chair; John Freitag was nominated as vice chair; Lauri Berkenkamp was nominated as recording secretary. Motion passed to elect all three. Motion was made, seconded, and passed to adopt the rules of procedure.

Lauri Berkenkamp questioned the need for a pre-town meeting.

Road and Highway Report

George Spaneas came to the board to ask questions about possibilities for paving the Justin Morrill Highway. Currently there are no plans to repave the road. Board noted that paving grants can only be used on Class 2 roads; discussion ensued regarding paving and costs. With the assistance of Road Foreman Jon MacKinnon, the board is working on an inventory of the paved roads and will have more information at the next selectboard meeting to discuss. The paving grant we are applying for, due on April 15th, will be based on what this study determines is the most effective use of the funds we have available for paving.

- Contracted plowing and sanding costs to date are \$13,129
- Class on pavement management and maintenance will be held April 3.
- Board members passed a motion to post the roads, and signed posting notifications; roads will be posted from March 13 to May 15, 2019.
- Motion passed to sign the annual financial plan for town highways.

Motion was made and seconded to approve minutes of February 27 and March 1. Board approved minutes of February 27 with no changes. Board approved minutes of March 1 with the note that 17 community members were in attendance and the spelling of Lauri Berkenkamp's name was corrected.
